- Landscape known as largest water consumer in urban sector.
- Improvements? Yes! Drier gutters? Yes!
- Annual Per Capita use down over 6% over 5 years. UCSD is attempting to achieve 4%.
- How – EFFICIENCY in mechanical devices for new and retrofit situations.

Don't forget EFFECTIVE

- My industry has developed control systems integrated with flow, daily weather, precipitation control by the minute.
- But have we left the operator behind? Yes.
- Assistance via Workforce programs needed to train true Water Managers (and improve their living situation).

The smallest are the greatest

- Beyond components for recycled water or heavily chlorinated potable water is this fact for our region.
- Most urban water in San Diego goes for outdoors. 30% has been reduced in 6 years. And most of that water is pushed out of sprayheads.
- **We use less, we pump less, we CO₂ less, we run-off to the ocean less.**

The Components

- Pop-up Sprayheads;
 - Nozzles improved from 50% efficient putting out 1.5" per hour to 80% efficient putting out 1" per hour.
 - Rotary Spray nozzles replace clunky large rotors and inefficient (and ineffective) spray nozzles
- The Light Bulb Story

Funding for long-term water management to include Landscape because.....

- We work to keep SD looking right + property values in check.
- We are large consumers of water.
- There are wasteful situations that can be repaired and lower long-term water / pumping / CO² issues.
- More recycled – or at least available in the warmer months – means acceptable purple pipe water pricing. And the Waiver is continued !!!
