

- Engage in providing comments/input to Regional Board
 - Improve/maximize inter-group interaction – networking, information sharing, funding
 - Educate Regional Board on impacts of policies
 - Representation on TRAP and other advisory panels
- Leverage joint stakeholder outreach
- Integrate Regional Board goals into IRWMP goals and objectives
- Provide tools for Regional Board to prepare permits, including shared data and maps

Draft IRWM Guidelines

- Outlines program terms and eligibility criteria
 - RAP approval
 - Adopted IRWM Plan
 - GWMP, UWMP, AB1420, and water meter compliance
- Presents new standards for IRWM Plans
 - 16 chapters; 5 are new
- Describes proposal review and selection process



Draft Planning Grant PSP



- Outlines eligibility criteria
 - IRWM Plan development or update
 - Focused planning, such as salt/nutrient or flood management
- Presents available grant funding
 - Maximum \$1M per Region with 50% funding match
 - Total \$20M Statewide
- Provides application instructions and submittal contents
 - 6 detailed attachments

Draft Implementation Grant PSP

- Outlines eligibility criteria
 - Consistent with adopted IRWM Plan
- Presents grant allocations
 - \$10.1M for San Diego Funding Area with 25% funding match
 - \$7.9M for Region per Tri-County MOU
 - Total \$100M Statewide
- Provides application instructions and submittal contents
 - 13 detailed attachments

Draft Stormwater Flood Management PSP



- Outlines eligibility criteria
 - Consistent with adopted IRWM Plan
 - Designed to manage stormwater runoff to reduce flooding
 - Address immediate public health and seismic safety issues
- Presents maximum grant award
 - \$30M per project with 50% match
 - Total \$212M Statewide
- Provides application instructions and submittal contents
 - 12 detailed attachments

Draft IRWM Guidelines and PSPs

- RWMG has drafted Comment Letter for submittal to DWR
 - Comment Letter will be distributed for RAC review
 - Comments are due by April 13th
- RWMG will incorporate RAC comments and transmit to DWR by April 23th deadline


