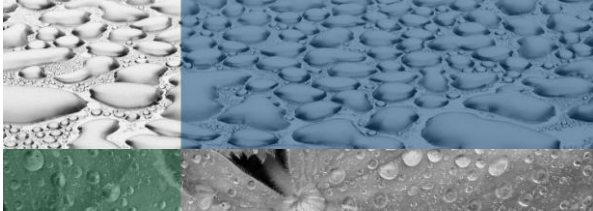

What is IRWM Planning?

- A regional approach for addressing water management issues preferred by:
 - Department of Water Resources
 - State Water Resources Control Board
- A mechanism for stakeholders to work together to effectively implement water management projects



Why is IRWM Important?



San Diego IRWM Program

- IRWM Mission
 - *...protecting, managing, and developing reliable and sustainable water resources...*
- Region Boundary
 - All or portions of eleven hydrologic units within San Diego County that discharge to coastal waters
- Active Participants
 - Regional Water Management Group
 - Regional Advisory Committee
 - Tri-County Funding Area Coordinating Committee



What Projects does IRWM Support?

- IRWM supports multi-benefit water management projects that:
 1. *Optimize water supply reliability.*
 2. *Protect and enhance water quality.*
 3. *Provide stewardship of our natural resources.*
 4. *Coordinate and integrate water resource management.*

Proposition 50 Provided First Wave of IRWM Grant Funding

- Passed by California voters in November 2002
- San Diego received \$25 million in project implementation funding

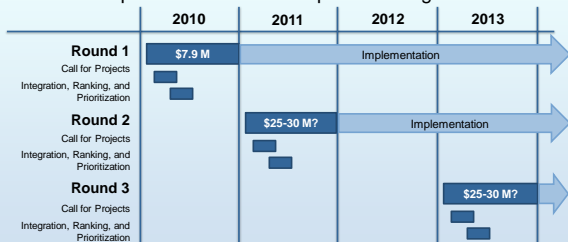
Proposition 84 Will Provide Second Wave of IRWM Grant Funding

- Passed by California voters in November 2006
- Provides \$1 billion for IRWM planning and implementation projects
 - \$91 million for San Diego Funding Area (incl. portions of Orange and Riverside Co)
 - \$71 million to San Diego Region through a formal agreement



San Diego IRWM Updates

DWR Anticipates 3 Rounds of Prop 84 Funding



Proposition 1E Will Provide Additional IRWM Grant Funding

- Passed by California voters in November 2006
- Provides \$300 million for IRWM projects addressing stormwater and flood management
 - Emphasis on addressing immediate public health and safety needs and strengthening existing flood control facilities to address seismic safety issues
 - Separate grant applications with \$30 million cap

Review of Prop 50 Grant Cycle

THEN

- Call for Projects
 - Concurrent with IRWM Plan development
 - Project Information Form was circulated via email
- Project Ranking
 - Section F outlines ranking criteria

NOW

- Call for Projects
 - Consistent with adopted IRWM Plan
 - Project information will be submitted through project database
- Project Ranking
 - Section F outlines ranking criteria

Review of Prop 50 Grant Cycle

THEN

- Project Selection
 - Occurred after ranking by a Workgroup designated by RAC
 - Selection criteria vetted with RAC

NOW

- Project Selection
 - Watershed groups have opportunity to provide comments
 - Will occur after ranking by a Workgroup designated by RAC
 - Selection criteria vetted with RAC

Lessons Learned from Prop 50

1. Limit your projected funding match.
 - Do not exaggerate total project costs; Break project into phases if appropriate.
2. Submit only ready-to-proceed projects.
 - Focus on those projects which are truly ready to go once the grant contract has been executed.
3. Local cost share must be spent before grant reimbursement.
 - Plan to document your funding match in early tasks.
4. IRWM grant can not fund staff positions.
 - Project work plans must be task-oriented.

- To facilitate partnerships, 'sharing' by two users is possible

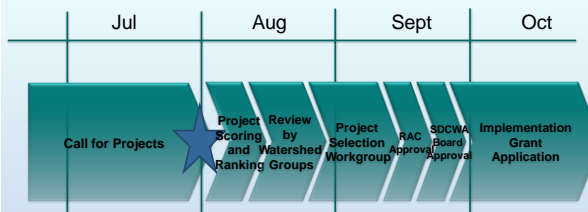


Call for Projects

- Projects submitted by **August 2, 2010** will be considered for Prop 84 Round 1 funding.
- Projects may be submitted after the deadline for consideration in future rounds.
- As each new grant cycle arises, announcements will go out to update or submit projects for consideration.

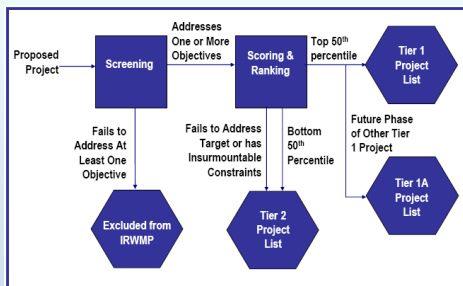
Tentative Timeline for Prop 84 Round 1

Project Scoring is Used to Identify Projects for Consideration



Step 1: Screening

- Screening Criteria – Pass/Fail
 - Addresses an IRWM Plan Objective
 - Addresses an IRWM Plan Target
 - Free from Insurmountable Constraints

Step 2: Project Scoring

Criterion	% of Score
1 Address Multiple IRWM Plan Objectives	23%
2 Integrates Multiple Strategies	23%
3 Spans Multiple Hydrologic Units	10%
4 Creates New Water	10%
5 Linked to Other Projects	10%
6 Involves more than One Entity	6%
7 Identified in Existing Plan	6%
8 Directly Benefits Disadvantaged Community	6%
9 Addresses Environmental Justice Concern	6%

What is Integration?

- Approach
 - Develop projects made up of integrated strategy groupings to accomplish Plan objectives
- Benefits
 - Water management, coordination, regulatory, public awareness, and cost savings benefits result from combining strategies



Step 3: Ranking

- Top 50th Percentile = Tier 1 or Tier 1A
 - Moves on to Project Selection Workgroup for consideration in current grant application
 - Note: Future phases of current Tier 1 projects will be designated Tier 1A
- Bottom 50th Percentile = Tier 2
 - Remains in IRWM project list for future grant cycles

Additional Criteria to Further Evaluate Tier 1 Projects for Funding

- Program Preferences / Statewide Priorities
- Regionalism
- Degree of Benefit
- Degree of Negative Impact
- Contribution to Measurable Targets
- Cost-Effectiveness
- Readiness to Proceed
- Amount Leveraged

Project Scoring Criteria

Criterion	% of Score
1 Address Multiple IRWM Plan Objectives	23%
2 Integrates Multiple Strategies	23%
3 Spans Multiple Hydrologic Units	10%
4 Creates New Water	10%
5 Linked to Other Projects	10%
6 Involves more than One Entity	6%
7 Identified in Existing Plan	6%
8 Directly Benefits Disadvantaged Community	6%
9 Addresses Environmental Justice Concern	6%

Project Database: Project Description Form



- List Project Partners (14)
 - Identify agencies and organizations who are project partners
- Identify Linkages with Other Projects (22)
 - Describe how the project is connected to and/or helps to implement other projects
- Local/Regional Plans Which List the Project (23)
 - To receive credit, the plan cited must specifically identify the proposed project

Project Database: Project Description Form



- Creates New Water (24)
 - Describe how the project creates new water
- Address Critical Water Supply and/or Quality Issues of a Disadvantaged Community (27)
 - To receive credit, the proposed project must clearly provide a direct benefit to a specific disadvantaged community

Project Database: Objectives Form



- IRWM Plan Objectives (1-9)
 - Project scoring is dependant on how many objectives are addressed by the project
- Affected Hydrologic Units (10-11)
 - Every project should address at least one of the region's 11 hydrologic units
 - 'Affected' does not imply a negative impact

Project Database: Strategies Form



- Water Management Strategies (1-31)
 - Project scoring is dependant on how many strategies are employed by the project
 - Be realistic about which water management strategies are actually being employed.
 - Be sure the selected water management strategies are project actions, not indirect benefits.

Examples of Projects Addressing Water Management Strategies

- Desalination
 - Developing potable water supplies through desalination of seawater or brackish groundwater
- Economic Incentives
 - Rebate programs to promote water conservation
- Matching Quality to Use
 - Recycled water and other non-potable projects
- Environmental and Habitat Protection
 - Land conservation
 - Wetlands creation and enhancement
- Water Quality Protection and Improvement
 - Stormwater capture and treatment

Examples of Project Not Addressing Water Management Strategies

- Potable Water Treatment and Distribution
 - Non-potable projects that offset potable use
- Groundwater Aquifer Remediation
 - Projects that recharge higher quality water but which do not actually remove pollutants from contaminated aquifers
- Water Transfers
 - Intra-regional water transfers
- Stakeholder/Community Involvement
 - Projects that engage public input solely through CEQA

Prop 84 Requirements

- SDCWA has primary contract with DWR
 - Subcontracts with all project proponents receiving grant funding
- Draft eligibility requirements:
 - Project must be submitted through San Diego IRWM project database by **August 2, 2010**
 - *Urban water suppliers* must be in compliance with UWMP Act and AB 1420
 - For groundwater recharge projects, Groundwater Management Plan must be prepared


Prop 84 Requirements

- Draft contract requirements:
 - Grant is a reimbursement for completed work
 - Invoicing and reimbursement cycle is 2-6 months
 - Funding Match = 25-50% of total project costs from non-State sources
 - Do not exaggerate total project costs; Break project into phases if appropriate.
 - 10% retention is withheld until project proponent has met all reporting requirements
 - All projects must be in compliance with CEQA
 - Labor Compliance Program is required for all public works projects
