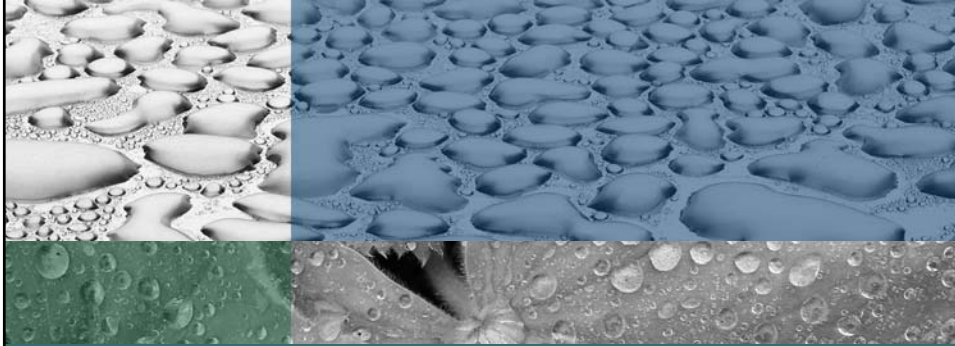

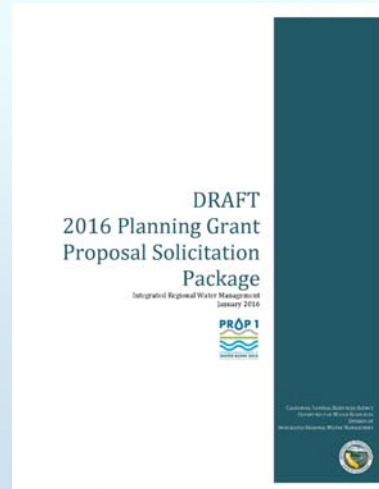

IRWM Planning Grant Solicitation

- \$5 million available statewide
- Eligible proposal types:
 - Preparing an IRWM Plan (DWR's priority)
 - \$1 million grant cap
 - Updating or improving an existing IRWM Plan
 - \$250,000 grant cap



IRWM Planning Grant Solicitation

- RWMG recommends submitting a Planning Grant application to prepare Stormwater Capture Feasibility Study
 - Analyze the feasibility of planning, constructing, operating, and managing facilities that capture stormwater for beneficial use
 - Update the IRWM Plan to incorporate analysis
 - Total grant request: \$250,000
 - Allocated from San Diego's \$38M total

RAC Discussion and Vote on IRWM Planning Grant

DAC Planning Grant Solicitation

- \$5.25M available for Funding Area
- ~\$4.1M for San Diego per Tri-County FACC split
 - Allocated from San Diego's \$38M total
 - Tri-County FACC partners have asked for allocation based on need (not traditional split)
- RWMG will coordinate with Tri-County FACC to prepare a joint proposal



**Tri-County Funding Area Coordinating
Committee (FACC)**

DAC Planning Grant Solicitation

- For activities that involve disadvantaged communities (DACs), economically distressed areas (EDAs), or underrepresented communities
- Focus is to fund project development activities that will lead to competitive, fundable projects that will leverage implementation funding
- “Non-competitive” solicitation – DWR requests one proposal from the entire Funding Area

- Total Grant Request: \$13.3M
- Anticipated Grant Funding Available: ~\$4.1M
- Scores released to Project Sponsors, RAC, and stakeholders: May 25th
- Maximum Score: 17 points

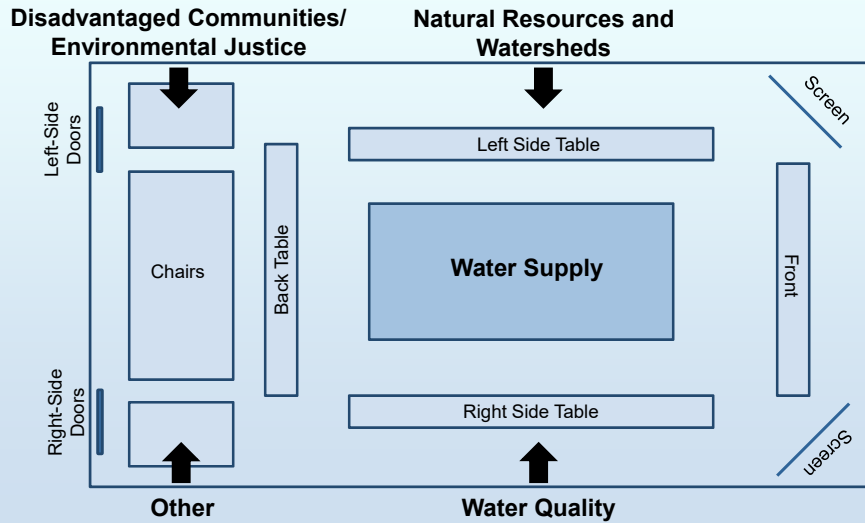

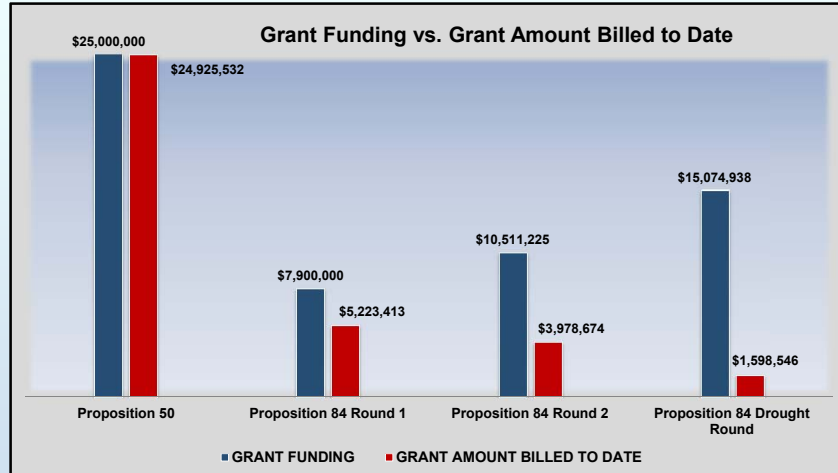

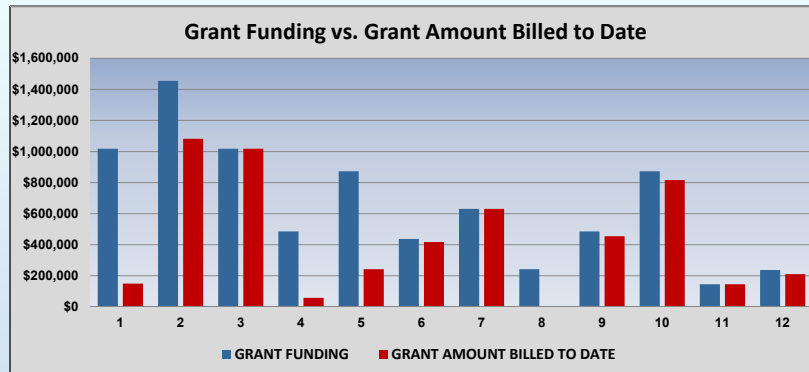

 - Amendment Request No. 1 routing for final DWR approval
- Upcoming:
 - North SD Regional Recycled Water – Design and construction for several subcomponents
 - Fail Safe Potable Reuse Project – Water data analysis, data handling and database develop for
 - Santa Margarita Nutrient Study – Groundwater testing

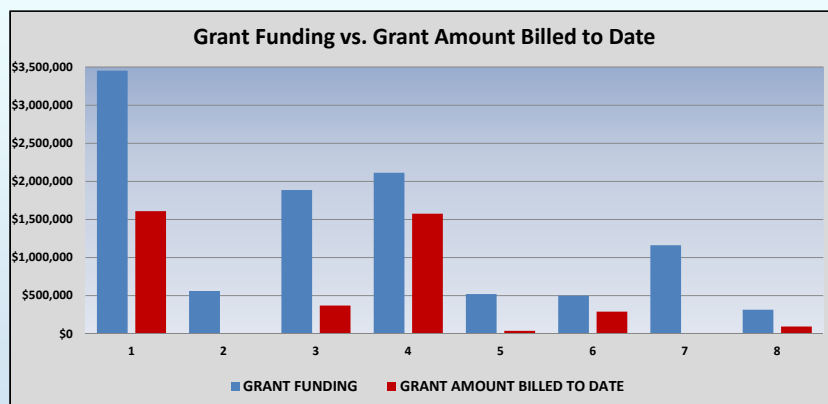

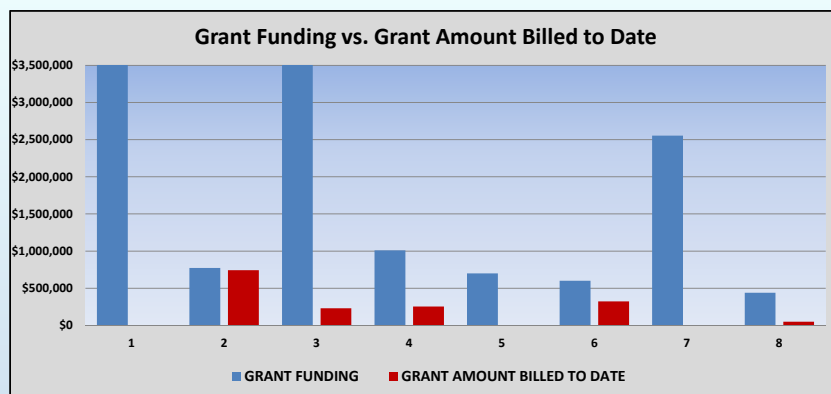


Proposition 84 Implementation, Rnd 3

- Significant Milestones:
 - Reynolds Groundwater Desalination Facility – Design and construction of conveyance pipeline continue
 - Carlsbad RWP Expansion – Began construction
 - Regional Emergency Storage – Completed Memo on Challenges and Opportunities
 - Rincon Customer-Driven Demand Management – Delivered 6,660 Home Water Reports
- Amendment Request No. 1 submitted
- Upcoming:
 - Continue with projects' construction
 - Rincon Customer-Driven Demand – Meters installation audit
 - Regional Demand Management – Outreach events scheduled

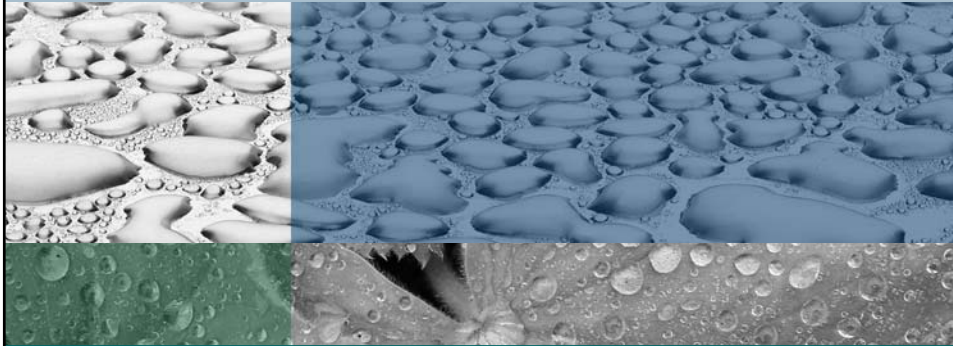
