- RAC directed staff to update targets based on comments at September 5 meeting

Measurable Targets for Objective C: Further the Scientific and Technical Foundation of Water Management

1. **By 2010, develop an agreed-upon system and metrics for tracking the progress of Basin plan validation efforts through coordination with Regional Board staff.**
2. Conduct water quality assessment for beneficial use attainment within 75% of surface waters by 2015.
4. By 2013, develop an agreed-upon system and metrics for tracking groundwater assessment information.
5. By 2015, develop an agreed-upon system and metrics for evaluating ocean water quality and marine habitat.

*Measurable Targets for Objective E:
Construct, operate and maintain a reliable
infrastructure system*

2. Increase local treatment of imported and local surface waters from 597 mgd to 860 mgd in 2010 and 921 mgd in 2030.

*Measurable Targets for Objective F: Reduce
the negative effects on waterways and
watershed health caused by
hydromodification and flooding*

3. By 2010, implement a system to track rates of change in impervious surfaces regionally.
 - Added language to discussion explaining goal of metric

*Measurable Targets for Objective G:
Effectively reduce sources of pollutants and
environmental stressors*

5. Reduce the frequency of sanitary sewer overflows in excess of 1,000 gallons from 180 overflows per year in 2005 to 120 overflows per year in 2012.

*Measurable Targets for Objective H:
Protect, restore and maintain habitat and open space*

1. Conserve by 2012 a minimum of 10,000 acres of habitat and open space, including functional riparian habitat and associated buffer habitat, and functional wetland habitat.
 2. Restore by 2012 a minimum of 1,000 acres of habitat and open space, functional riparian habitat and associated buffer habitat, and functional wetland habitat.
 3. Remove a minimum of 1,000 acres of non-native invasive plants by 2012.
 4. Monitor, manage, and control nuisance aquatic species in the Region.
- Added text supporting MSCP and HCP/NCCP implementation

Dates	RAC Involvement
Dec 2006 – July 2007	RAC meetings - provided input on major elements of plan (i.e. objectives, targets, regional priorities, prioritization)
April 2007	Provided comments on Administrative Draft IRWM Plan
July 2007	Provided comments on Public Review Draft IRWM Plan
July 10, 2007	Unanimously recommended SDCWA Board accept Public Review Draft (SDCWA Board accepted in Aug.)
Sept 5, 2007	Reviewed major revisions to Public Review Draft and provided further comments
Sept 19, 2007	RAC consider recommending to RWMG governing bodies approval of 2007 IRWM Plan

Revisions to IRWM Plan based on RAC Input (Sept. 5th meeting)

- Expanded language on relationship between the City of San Diego and Water Authority (Section A)
- Revised measurable targets (Section C)
- Added language stating that targets achieved through combined efforts of agencies, NGOs, etc. (Section C)

Revisions to IRWM Plan based on RAC Input (Sept. 5th meeting) (continued)

- Noted that targets are based on current adopted local plans and will evolve based on changing conditions (Section C)
- Added language to ensure watershed approach will be evaluated in formation of institutional structure. (Section G)
- Included brief description of Borrego IRWM effort and associated coordination (Sections B and O)

- Clearly defined evaluation criteria
 - Support and improve local and regional water supply reliability
 - Contribute expeditiously and measurably to the long-term attainment and maintenance of water quality standards
 - Eliminate or significantly reduce pollution in impaired waters and sensitive habitat areas, including ASBSs
 - Include safe drinking water and water quality projects that serve disadvantaged communities
- Initiated discussion and assessment of each project

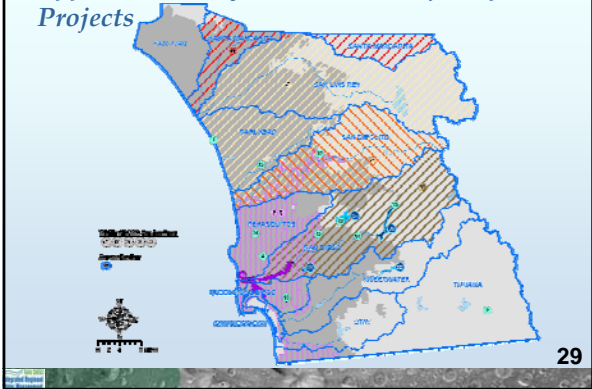

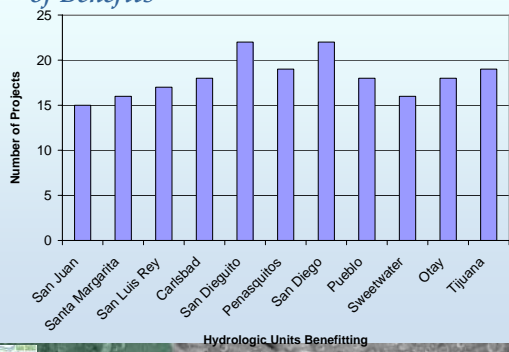

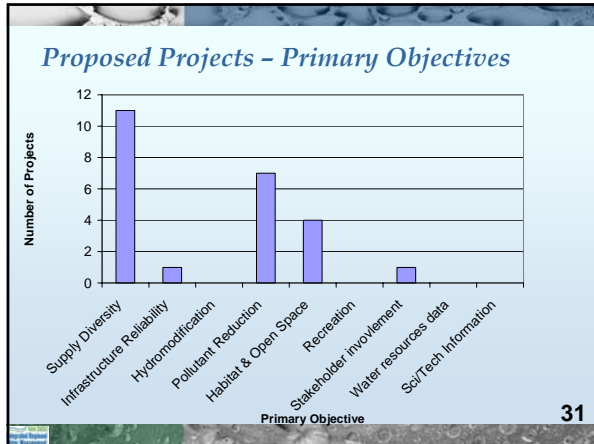

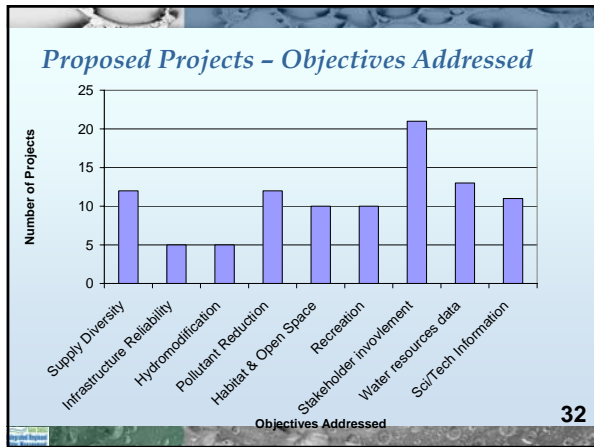
Approximate Physical Location of Proposed Projects

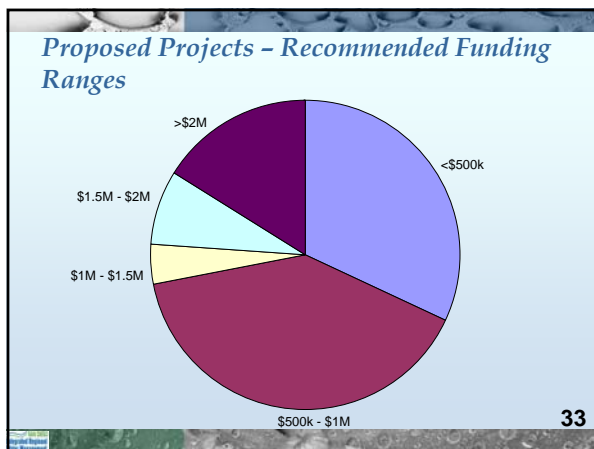


Proposed Projects - Approximate Location of Benefits









Upcoming Meetings: Potential Meeting 5

- Projects may become infeasible/unfundable prior to the January submittal date
- Develop proposed approach to determining how to revise package if projects “fall out” before January
 - Analysis required for application and time constraints prevent addition of replacement projects
 - Workgroup recommends developing a formula to redistribute funds among proposed projects
